I write further to your request FOI ID 46755 under the Freedom of Information Act 2000 regarding: -

Memory Assessment Services - Brain Scan Referrals, Professionals within service and Post Diagnostic Support

Your request is set out below:

1. Do you offer a specialist Memory Assessment Service?

**Yes**

2. If you have a specialist MAS,

a. are people routinely offered a brain scan: either CT or MRI, and if so which?

**Currently practise varies across the MAS services however the Trust is working towards patients being offered a scan dependent upon need and complexity.**

b. which professionals are available as part of the memory clinic service offer, e.g., psychiatric nurse, general nurse, old-age psychiatrist, neurologist, psychologist, occupational therapist, social worker etc, please state

**Psychiatric nurses, old-age psychiatrists, psychologists and occupational therapists are available. These roles will provide assessment/ diagnosis and/or post diagnostic intervention. Please note our post diagnostic interventions sit within a different service, our MAS teams are for assessment and diagnosis only.**

c. once people have received a diagnosis, what is the standard offer in terms of post diagnostic support? Please describe

**Every patient diagnosed with dementia (and/or their carer) is offered a face to face post diagnostic appointment to discuss their diagnosis and includes advice on coping and memory strategies, healthy living, driving, future planning and local support available. There is also an option to attend groups including Living Well with Dementia and Cognitive Stimulation Therapy and our psychologists can offer tailored post diagnostic counselling for those individuals struggling more with their diagnosis, for example young onset dementia.**

d. does the memory clinic keep people on for regular review or are they discharged to their GP or another service?

**The MAS assessment and diagnosis service does not hold patients to undertake regular reviews and will either discharge to GP or move the individual into the teams which offer post diagnostic interventions**
