Your request is set out below:

For each individual memory assessment service you operate:

1. The service's annual funding for each of the years 2018-2024 inclusive.

Memory Assessment services are one part of the provision to Older Adults with mental health needs that sit within our Community Mental Health Services for Older People (CMHSOP). These services are funded through a block of income from our local ICB (now Kent & Medway ICB). The funding is not split between Memory Assessment and other mental health services for Older Adults, and is not split between teams. As such, we cannot provide an answer to funding for Memory Assessments as a standalone service.

2. The source/s of funding for the service for each of the years 2018-2024 inclusive.

We are however able to provide the data requested for the time period 2021-2025 (present date). Please note if a patient has an appointment in more than one year they will be included in the count for both years.
