**Please see below table which provides the make, model and number of vehicles leased and/or owned during the period dated 01/09/2023 – 31/10/2024. All leased vehicles were for Trust business use only and not personal use.**

The Trust are unable to release the registration number of each of these vehicles as this is deemed to be personal data by the DVLA. By releasing this information into the public domain, it could identify an individual who is carrying out their organisational public duties. Therefore, under Section 40(2), by way of section 40(3A)(a) personal data of any person (third party data) is exempt under section 40(2) if disclosure would breach one of the data protection principles. This aspect of Section 40 is an Absolute Exemption and is therefore not subject to the Public Interest Test. It is therefore subject to the provisions of the UK Data Protection Act (2018). We believe that to disclose this would be likely to breach the first Principle of the Data Protection Act by unfairly contravening right to privacy and confidentiality.
